DESCRIPTIONS, ELIGIBILITY, PROCEDURES & TIME REQUIREMENTS

CHALLENGE DESCRIPTIONS

◆ LEVELS 2, 3

CONSUMER MATH CHALLENGE), an individual event, is an applied academic math test which allows participants to complete everyday consumer challenges related to Family and Consumer Sciences subject matter, including personal finance and consumer education concepts.

FCCLA KNOWLEDGE BOWL CHALLENGE, an individual event, is a knowledge and skill test which allows participants to demonstrate their knowledge of FCCLA's programs, activities, leadership, and chapter management.

NUTRITION CHALLENGE, an individual event, is a knowledge and skill test which allows participants to demonstrate their knowledge of nutrition, wellness, and health concepts.

CULINARY MATH CHALLENGE, an individual event, is an applied academic math test which shows participants to solve common culinary arts programs using math skills including measurements, fractions, decimals, conversions, yield per cents and costs.

LEVELS

Level 2: Grades 9-10

Level 3: Grades 11-12

Eligibility:

1. Chapters may have up to a total of 30 participants—10 in each level.
2. Participation is open to any affiliated ND FCCLA member.
3. Any one member may participate in ONLY TWO testing events.
4. Each participant must complete the registration form.

Registration Process:

1. [Fill out this form to register](#) your students for online testing. **Plan ahead** as **PAYMENT MUST BE RECEIVED** in the state office no later than **FEBRUARY 9th, 2024**.
2. Testing links will be emailed to the chapter adviser the Friday immediately preceding the start date of each testing category. These tests are timed.
3. The state office will email the chapter adviser one invoice to pay all of the registration fees with one check.

Procedures & Time Requirements:

1. Participants must complete an online test during the designated testing window:
FCCLA Knowledge Challenge: February 12-16, 2024
Consumer Math Challenge: February 19-23, 2024:
Nutrition Challenge: February 26 – March 1, 2024
Culinary Math Challenge: March 4-8, 2024
2. The online link to the test will be emailed to chapter advisers with FCCLA members registered to participate 24 hours prior to the start of the competition.
3. The participants will have assigned seating.
4. Students may use a calculator BUT **may not use** calculator apps on any electronic device.
5. It is highly recommended that the chapter adviser or an assigned adult supervise the administration of the test whether this is done virtually or in the classroom.
6. Tests will be scored electronically.
7. One point per question for correct answers will be awarded to the individual; points will not be lost for incorrect answers.
8. Tests will NOT be returned to the individual participant.
9. Test Questions Total:

LEVEL 2: 50 questions

LEVEL 3: 50 questions

10. The total time required for this event is approximately 45 minutes.
